<b><u>Rule 5 (4) :</u></b> The teachers shifted under Rationalisation i.e. Primary Schools and Upper Primary Schools (SGT Category), shall also participate in the Transfers Counseling.	<b><u>Rule 5 (4) :</u></b> The teachers shifted under Rationalisation i.e. Primary Schools and Upper Primary Schools and SGTs in High Schools (provided if required number of teacher posts are sanctioned in High Schools) shall also participate in the Transfers Counseling.
<b><u>Rule 6 II (d):</u></b> Ten (10) points to the Headmaster Gr.II Gazetted / Teacher who is working as NCC Officer.	<b><u>Rule 6 II (d):</u></b> Ten (10) points to the Headmaster Gr.II Gazetted / Teacher who is working as NCC Officer, if they have completed 8 years service in the School
<b><u>Rule 8 Note -2:</u></b> The Headmaster Grade-II Gazetted / Teachers should avail either the preferential category (Rule 8) or the special points {Rule 6 (II) (d & e)} once in 8 years and an entry be made in SR.	<b><u>Rule 8 Note -2:</u></b> The Headmaster Grade-II Gazetted / Teachers should avail either the preferential category (Rule 8) or the special points (Rule 6 (II) (c)) once in 8 years and an entry be made in SR.
<b><u>Rule 9 (1)(b) :</u></b> All the vacancies arising due to compulsory transfers as per 5 Rule 5.	<b><u>Rule 9 (1)(b) :</u></b> All the vacancies arising due to compulsory transfers as per Rule 5.
