III. High Schools:

The following steps shall be followed to assess the requirement of Vidya Volunteers in High Schools.

- Existing teachers in High Schools shall be divided in to 3:2 ratios. SSA quota will be 3 parts.
- 2 Entitlement shall be calculated as per the following norms.
 - One Teacher /Vidya Volunteer per each class of Elementary level (i.e classes VI to VIII).
 - One additional Teacher /Vidya Volunteer for every additional section or for every 60 children.
- The requirement of Vidya Volunteers would be the number comes after subtracting SSA quota of existing teachers from entitlement.
