The RMSA Andhra Pradesh, Hyderabad proposed to provide orientation programme to the members of SMDCs of Secondary Schools at District level during April/May 2013 i.e. in summer vacation to provide sufficient awareness on the role and responsibilities of the members of SMDC on all the activities of RMSA at School level for their effective participation and discharge of duties for benefit of the development of the school.

For this purpose SRPs and DRPs @two and ten respectively from each district were already trained and required modules were also kept ready both in Telugu and Urdu media. As the schools are fully engaged with Public/Annual examination activities, it is decided to provide 3-day orientation to SMDC members during summer vacation, April/May 2013. The DEOs are requested to identify suitable venues to provide training at every divisional level of the district. The state office will be sending the schedule of a programme and the time table shortly. Also observers from the state office will be posted to see that the programme goes systematically and purposefully.

To provide the orientation programme for 3days @ 4 members from each SMDC of the Secondary School i.e. one headmaster, one senior school assistant (joint signatory) and two parents (one being from reserved communities i.e. SC/ST/BC), an amount of Rs.550/- per participant is hereby ordered for release as per the details given below.
